#### CALL TO ORDER:

# **APPROVE AGENDA:**

Councilor Parker moved to approve the meeting agenda with the addition of 8c – Special Event Request. The motion was seconded by Councilor Vandal and carried unanimously.

#### **Approval of June 25, 2018 Council Minutes**

Motion made by Councilor Vandal to adopt Resolution 2018-06 Regarding Primary and General Elections increasing election judge wages. Motion seconded by Councilor Soderberg and carried unanimously.
